#### **Fundraising Event and Activity**

A fundraising event was organised during the financial year on behalf of St. Luke's Eldercare Centre at Telok Blangah Way, for the purpose of supporting the operations of the Centre in caring for the aged and elderly. A total of \$34,425 was raised from church members and donated to the Centre.

# 5. REVIEW OF FINANCIAL STATE AND EXPLANATION OF MAJOR FINANCIAL TRANSACTIONS

The church has a net surplus of \$231,516 after provision for depreciation. The church has sufficient resources to support its operations, and there were no extraordinary or unexpected major financial transactions during this financial year.

#### 6. REVIEW AND CHANGES IN POLICY

For this financial year, no major policy changes were made, nor new policies approved.

# 7. EXPLANATION OF THE PURPOSES FOR WHICH THE CHARITY'S ASSETS ARE HELD

The land and building at 235 Telok Ayer Street and 61 Wishart Road are held in trust by the Secretary of the Trustees of the Methodist Church in Singapore. They are used for the purpose of promoting and conducting the church's activities.

#### 8. FUTURE PLANS AND COMMITMENTS

There are no major plans and commitments at this stage.

## 9. STATEMENT OF ACCOUNTS

The audited statement of accounts for the financial year ending 31 July 2017 is attached.

Overseas expenditure was disbursed from the Mission Fund, which was established for the purpose of mission awareness and activities. Total overseas expenditure from the Mission Fund amounted to \$58,506.94 for the financial year. Of this sum, \$38,706.94 was for missions expenses (including overseas support costs), and \$19,800 was for overseas missionary support costs in countries such as China, Nepal, and Thailand.

Total Related Party transactions of \$360,638 refers to the payment of salaries and related costs to the Methodist Church in Singapore for pastoral support.
